The purpose of this clinic is: To educate individuals on proper saddle fit and to provide an education to enable the participant to determine improper saddle fit on their personal horses. Participants will be educated on how to visually determine if a saddle is fitting a horse, as well as how to put their hands under the saddle to feel the less obvious areas of saddle suitability. Therefore the participants will be invited into the personal space of other participants' horses to feel underneath a saddle that has been set upon the horses back in an effort to educate the individual how to "feel" if the saddle fit is correct or incorrect. Therefore the participant (you) will accept full responsibility and liability for being in close proximity to an unfamiliar horse. Your understanding, retention and subsequent use of this information and techniques, is also, your responsibility since comprehension varies person to person.
